

# THE DECLARATION OF INDEPENDENCE OREGON PLATFORM

## Proposed Solution for Clean Elections

Secretary of State does not need to administer the voter rolls, we do not need our voting history tracked & we must end universal mail ballots, replace with County administered voter rolls that cycle every 2 years. How It Works:

1. On election day, show up at your local precinct.
2. You therefore can only vote 1 time, In person voting prevents a vote in 2 states ( by mail?)
3. Show proof of citizenship, Govt. ID, sign for ballot and new 2 year voter registration form
4. Fill out your same day registration form.
5. Complete your ballot.
6. Drop registration in box 1, and ballot in box 2.

The # of registrations matches the # of ballots (self auditing at the precinct level)

The registrations are only done in person on election day and kept for 24 months. If you cannot register in person, with ID in front of an official, you must use absentee method with copy of ID.

7. Your precinct counts the Paper Ballots, certifies count, & # of registrations with multiple observers
8. Election totals are communicated securely to the county by precinct captains.
9. Ballot and Reg. lock boxes are escorted to the county by an approved official, clergy, fire, police etc.
10. At new election you register again, instant audit, no vote history, motor voter, or statewide online
11. The County database is used to print the precinct poll books for the next election cycle.
12. Absentee mail ballots and registrations only allowed for disabled & military out of country voters
13. This system prevents the need to purge rolls, find deaths, address changes, etc.

Universal Mail In Voting is ripe with potential fraud and must be abolished.

## **DRAFT POTENTIAL PLATFORM ITEMS** **(OPEN FOR COMMUNITY DISCUSSION)**

### **Lower Property Taxes**

The ever increasing Property taxation, even with the Measure 50 limit of 3% per year, is not sustainable because there is no end in sight. Unlimited taxation, is a recipe for bloated county budgets on the backs of the poor taxpayers and is unconstitutional because we the people have no recourse to keep those bloated budgets in check.

The county must provide basic services and do so within a fixed budget. The threat of the loss of your home if you do not pay must end. Our proposal would start with what is fair to the property owner so that basic services such as fire response, law enforcement and other critical beneficial services to the local community can be provided within a reasonable budget, simultaneously limiting the wasteful spending of county governments. The solution? Preserve what we have now with common sense cuts, and limit the property tax to **an amount that will never increase for the life of the property owner**, with potential adjustments if the actual need can be proven to the public with a hearing and a vote by the citizens.

Example: A 2 acre single family residence that is the primary residence, will be taxed no higher than \$750 per year. This tax limit only applies to SFH and not to commercial, industrial or income property. (rental units)

**Upon the sale of said property** a revaluation of the property tax will be based on the sale price as a percentage for the tax year in which it was sold. **The ongoing rate will remain fixed for the new owner and shall not increase more than 3% of the previous owners fixed rate.** The result of lower property taxes in Oregon is a migration of new homeowners from other states and property development, which will ultimately thin out the timber producing areas with planned communities, lowering the risk of large wildfires, and also results in more revenue for those counties.

### **Restoring Sanity to Public Schools.**

Oregonians should no longer be required fund public education with their property taxes unless they actually have children in those schools. We the People should not be forced by a very small percentage (3%) of society to financially support their agendas in order that they may recruit or convert more members. **Teaching or not teaching children about sexual preferences and lifestyles is the responsibility of the parents.** Their right to teach or not teach these specific subjects and raise their children must be according to their own cultural norms, never as subjects mandated by the Government. Government Schools that teach these subjects are in violation of the Church / State doctrine, as they have become proponents of a type of religion or lifestyle. We support the basics of education, the ability to read, write and become self sufficient with the skills needed to earn a living and pursue higher education. Subjects related to constantly changing cultural lifestyle issues or sexuality, gender and the like are the domain of families and their personal religious institutions, not the State.

Furthermore, **if it is true that people are born with a specific sexual proclivity and that it is never taught as a lifestyle or a choice to make,** then there is no need to recruit or teach to children because they were born in such a way that cannot be changed. Why then are we wasting time forcing kids to read such materials?

At a minimum, mental health issues such as anger control, and respect for other peoples beliefs should be discussed at the high school grade level. But **promotion of lifestyles as a tool of a specific group to gain control over our children in a mandatory classroom course that must be taught to primary school children, becomes therefore unconstitutional.**

### **Cash as currency in Oregon**

No Digital ID, No Digital currency, No ability to track or limit our spending.  
No ability to restrict our spending choices to specific places or items for any reason.

### **Adoption Reform**

Serious discussion on protecting the family, making adoption organizations accountable to the citizens while ensuring integrity and transparency for all involved. This can help with unplanned pregnancy as an alternative to other less desirable solutions.

### **2nd Amendment**

We support making Oregon a castle state. If a person brandishing a weapon with intent to harm or kill enters the interior of our home forcefully, **we should always have the unquestioned right** to protect our selves and family with deadly force if our lives are being threatened.

### **State & National Defense**

The existence of the Militia of the State of Oregon is required both by the Constitution of the United States and the Constitution of the State of Oregon, that it is primarily for the defense of our State and secondarily for the assistance of the other States in their defense. There is no authorization for its replacement in name or function by the National Guard. **We repudiate the concept that the National Guard is an extension of the army of the United States to be used for the purpose of invading foreign jurisdictions or enforcing United Nations mandates,** a concept that is doubly repugnant when no constitutionally declared war exists.

### **Legal Immigration Reform**

We demand that the National government make stemming the invasion of illegal aliens across our borders a top priority. We stand against the current practice of rewarding the offspring of such invaders with United States citizenship and the extension of tax payer funded benefits to such invaders and their families. Reforms are much needed to allow vetted and productive America First migrants to apply for resident permissions without waiting many years. In addition we must finish the border

security measures, stop wasteful welfare for illegals, stop incentives for illegal migrants and ensure gangs, terrorists, and invaders are prevented from entering without self identifying. All persons seeking entry across our borders state and national must prove residency, or verified right to be present within our Country. Resident Alien applicants must show intention to work within our society for its betterment. All legal migrants must have a Sponsor who is verified as requiring their labor in actual employment with full adherence to employment laws. No Fake Sponsors.

### **English Must Be the Official State Language**

We declare that statehood involves a common culture and language, and we do not consent to multicultural and multilingual programs forced upon us at our expense. We call for the recognition of English as our official state language and the requirement that all government documents, including ballots, be printed in English only.

### **Common Sense Compassionate and Efficient Assistance for the Homeless**

Affordable monolithic dome housing as an option for homeless citizens who have lost their home, subsidized by the state, with a zero interest loan to be paid back over 20 years, for anyone able to earn at least \$10.00 per hour, or owned outright by each county as temporary shelters...

The creation of county mental health institutions to treat and/or care for those who are unstable, who have no family support structure, who are struggling with addiction and cannot care for themselves is preferred over "freeway overpass" lifestyles.

Non-Aggressive Panhandling should be a constitutional right as a form of free speech so long as it is on public property and not endangering anyone's travel or other rights. No trespassing on private property or solicitation allowed.

### **Reforming Taxpayer Funded Welfare**

These benefits should only be for Citizens who are elderly, disabled, or unable to work. Able bodied between 18 and 55 who can work should be offered help if they are seeking work and can prove they are actively seeking employment. If there are small children affected, they must get WIC to promote the well being of those children. Welfare and disability funds are paid for by US Citizens and should only be used to help US Citizens. No Free Ride for non citizens. **If you are a non citizen we will have compassion for you in emergency life threatening situations.**

### **Constitutional Right to Homesteading and Self Sufficiency**

All people in the State have the Constitutional right to life liberty and pursuit of happiness and their ability to feed themselves by growing their own food or raising livestock shall not be infringed, as long as the livestock are tended in a humane fashion and the acreage of land used can support the number of animals in reasonable health.

### **Protect the Environment with Sound Policy and Limited Government**

We reject the idea that there is any substantial climate change that can be mitigated by taxation or restrictions on our personal lives or freedoms. **We reject the claim of peer reviewed scientific proof that climate change is something that is suddenly a threat caused by human activity.** Therefore the creation of and voting upon a reasonable set of regulations for industry by the citizens, should be the limit of state control in protecting lakes, rivers, beaches and the collection of trash on the state highways and parks among other industrial regulations that protect the health of Oregonians. We The People must have a say in all regulations, no more elite globalist marching orders by entrenched special interests.
